
Review period in brief

- Net sales in the review period were at the same level as in the corresponding period in the previous year.
- Order book at end of period was at the same level as in the corresponding period in the previous year.
- Result after financial items improved from previous year in consequence of enhanced operations in Cast Components.
- The Group had no one-time items during the review period.
- Operating losses at Karkkila foundry and Heerlen furan foundry declined from previous year, but weakened the operating result of Cast Components.
- The price of scrap steel started to pick up towards the end of the second quarter.

- Deliveries by customer sector were as follows:







Equity ratio, %




Division of sales

Sales by business group *)







Sales to heavy truck industry




Sales to off-road industry



Sales to machine building industry




Sales to power and transmission industry



Operating profit before one-time items




Performance of Foundries division


- The division contains the Group's foundries in Karkkila, Pori, Pietarsaari and Weert as well as the HWS business unit at the Heerlen foundry.
- Net sales were MEUR 94.8 (MEUR 92.1) and operating profit MEUR 7.1 (MEUR 3.5).
- The operating profit improved from the previous year mainly due to raising efficiency in operations.
- The Karkkila foundry's operating loss in the first half of the year was MEUR -2.7 (MEUR -3.1). The programme to enhance operations underway at Karkkila is expected to reduce the unit's operating loss from the previous year.
- Second quarter net sales were MEUR 48.9 (MEUR 47.0) and operating profit MEUR 3.8 (MEUR 2.0).

Operating profit before non recurring items




Performance of Machine Shops division


- The division consists of the Främmestad, Åmål and Albin machine shops in Sweden, the machine shops in Pori and Pietarsaari in Finland, and the machine shop functions in the Netherlands.
- Net sales in January June were MEUR 79.5 (MEUR 74.3) and operating profit was MEUR 4.6 (MEUR 3.5).
- The investments carried out in 2004 and 2005 increased the division's sales and improved the efficiency of its operations.
- Second quarter net sales were MEUR 39.2 (MEUR 37.5) and operating profit MEUR 2.0 (MEUR 1.6).

Operating profit before non recurring items




Performance of Heavy Components division


- The division contains the Group's furan foundries in Iisalmi, Finland and in Heerlen, the Netherlands, and the machine shops Componenta Nisamo in Lempäälä and Componenta Pistons in Pietarsaari.
- Net sales in January June were MEUR 28.9 (MEUR 24.1) and operating result was MEUR 0.5 (MEUR -0.8).
- Operating result improved from the previous year mainly due to the growth in sales and the improved efficiency in the operations of the Heerlen furan foundry.
- The Heerlen furan foundry made an operating loss in the first half of the year of EUR -1.2 (-2.2) million. The programme to stabilize and enhance operations is expected to continue to reduce the unit's operating loss during the current year.
- Second quarter net sales were MEUR 15.0 (MEUR 13.6) and operating profit MEUR 0.6 (MEUR 0.1).

Performance of Other Business

- Other Business net sales in January June totalled MEUR 24.1 (MEUR 28.2) and operating profit excluding one-time items MEUR 0.6 (MEUR 2.3).
- Sales by the Wirsbo forges fell 16% from the previous year to MEUR 23.2 and the operating profit for the first half of the year declined from the previous year mainly due to the lower sales.
- Componenta's share of the result of associated companies was MEUR 0.8 (MEUR 1.4).
 - Associated company Ulefos NV had net sales of MEUR 18.7 (MEUR 19.4)
 and profit after financial items of MEUR 2.0 (MEUR 2.3).
- Other Business had second quarter net sales of MEUR 11.4 (MEUR 13.6) and operating profit excluding one-time items of MEUR 0.2 (MEUR 0.7).

Prospects Q3/2006

- Componenta's prospects in 2006 are based on general external financial indicators, order forecasts given by customers, and on Componenta's order intake and order book.
- Demand for heavy truck components in January June 2006 fell short of the corresponding period in the previous year. The introduction of new environmental standards in Europe on 1 October 2006 coupled with improved economic prospects has increased demand for heavy trucks in Europe at least in the short term.
- Demand for components from the off-road and power and transmission industries and from machinery and equipment manufacturers increased in the first half of the year.

Prospects Q3/2006

- Running in the investments carried out in 2004 and 2005 at Karkkila and Heerlen continues operationally during 2006. The goal is to reduce the operating losses at these units during 2006 and to achieve an operating profit at the Karkkila and Heerlen units, as elsewhere, in 2007.
- Componenta's order book at the end of the second quarter of 2006 stood at the same level as at the same time in the previous year.
- Net sales and the result after financial items, excluding one-time items, in the third quarter of 2006 are expected to improve on the corresponding period of the previous year.
